**In order to provide services, the following form must be signed and dated.**

Superdogs Daycare, LLC Policies:

By choosing to employ the services at Superdogs Daycare, LLC, I agree to the following policies and items listed in the Waiver and Agreement section below.

- All dogs must be leashed on a nylon, leather or rope type leash. NO retractable or chain leashes, when entering and exiting Superdogs Daycare, LLC.
- Dogs attending Grooming services at Superdogs Daycare, LLC must provide proof of a current Rabies vaccination record with a completed and signed Superdogs Daycare, LLC Grooming Service Request Form and Waiver on file. The Owner is responsible for supplying all required medical information.
- Dogs must be in good health. Dogs must be free of all internal and external parasites. Any dog exhibiting any sign of illness will be promptly quarantined and sent home. Dogs who have recovered from a communicable illness will require written consent from their Veterinarian before they will be allowed to return to Superdogs Daycare, LLC.
- Any dog presented for Grooming services with fleas will be bathed with flea shampoo at the Owner's expense. In the event that flea shampoo is out of stock, the owner will be contacted for pick up.
- Superdogs Daycare, LLC will not allow any known or suspected aggressive dogs to attend Grooming services. It is the Owner's responsibility to disclose any aggressive or threatening behavior exhibited by their dog toward any person or dog.
- Female dogs in season may not attend Grooming services as the odor tends to cause behavioral problems in other dogs. They may return for Grooming services two weeks after they have stopped bleeding.
- After a surgery, any dog may not attend Grooming services for 14 days post-surgery unless Superdogs Daycare, LLC is provided with written consent from their Veterinarian.

Waiver and Agreement:

- a. I agree with all of the terms listed herein.
- b. I agree to pay for all charges incurred by my dog while my dog is attending Superdogs Daycare, LLC for daycare and/or grooming. Fees including but not limited to; daycare and daycare late fees, grooming fees, additional grooming charges, flea and/or tick baths/removal.
- c. I acknowledge the risks involved with communal facilities. Superdogs Daycare, LLC will always offer reasonable care, however, given the unpredictable nature and personality of dogs some unexpected injury may occur.
- d. I authorize Superdogs Daycare, LLC to obtain the vaccination records for your dog from his/her Veterinarian.
- e. In the event my dog is matted, I authorize Superdogs Daycare, LLC to remove matting by shaving my dog. I understand this is the most humane treatment for removing the matting from my dog and that my dog's hair will grow back, unless underlying skin and/or health conditions are present. I hereby release Superdogs Daycare, LLC from any liability associated with any injuries or medical problems that may be uncovered and/or occur during the clipping and de-matting process. Should my dog need veterinarian care after or during the process of de-matting, I agree to pay all veterinarian fees.
- f. In the event my dog appears ill or injured to the Superdogs Daycare, LLC staff, I authorize Superdogs Daycare, LLC staff to engage the services of the Veterinarian of Superdogs Daycare, LLC's choosing if my dog's Veterinarian cannot be reached or in the event my dog needs more immediate attention than his or her own Veterinarian can provide. I agree to pay for all medical services incurred by my dog while in the care of Superdogs Daycare, LLC. Superdogs Daycare, LLC has my permission to use any credit card information I have on file with Superdogs Daycare, LLC in the event I am unable to be reached by Superdogs Daycare, LLC. I release Superdogs Daycare, LLC from any medical expenses for the care of my dog.
- g. I release Superdogs Daycare, LLC, its employees, volunteers from any and all manner of damages, claims, liabilities, losses, costs, expenses, cause of action or lawsuits, attorney's fees, court costs and related costs arising out of or related to the services provided by Superdogs Daycare, LLC except which costs may arise from gross neglect, negligence or willful misconduct by Superdogs Daycare, LLC.
- h. I will not hold Superdogs Daycare, LLC, its employees or volunteers liable for the loss of my dog due to fire, theft, death, elopement, injury or illness and hold Superdogs Daycare, LLC harmless from any claims for any losses unless due to gross negligence by Superdogs Daycare, LLC.
- i. I affirm I am the legal owner of my dog and to my knowledge my dog has not been exposed to any communicable disease including but not limited to parvo, rabies, distemper, mange, ringworm in the last 30 days. My dog has been inoculated as documented on his or her vaccination records.
- j. I guarantee all information collected is true and no information including illness, communicable disease, health diagnosis, human or dog aggression or history of biting has been withheld in an attempt to enroll my dog into daycare or grooming.
- k. I understand that if my dog has not been picked up within seven days of the appointed time, my dog may be considered abandoned under RSA 438:18-20.
- l. I have read this waiver and agreement to its entirety. I agree and accept all rules, policies, requirements and conditions of this agreement and as the owner of this dog, I have the express right to enlist services by Superdogs Daycare, LLC.
